1. Introduction

Fill Wise ("we", "our", or "us") is committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our Fill Wise Chrome extension (the "Service").

2. Information We Collect

2.1. Information You Provide

We collect information that you voluntarily provide when using our Service:

- Google account information for authentication
- Payment information
- Form content you choose to fill using our Service
- User preferences and settings

2.2. Automatically Collected Information

We automatically collect certain information when you use the Service:

- Usage statistics (number of forms filled)
- Extension interaction data
- Technical information about your browser and device
- Error reports and performance data

2.3. Al-Related Data Collection

When using our Al-powered features:

- Text input provided for form filling
- Generated content statistics
- Form completion patterns

3. How We Use Your Information

We use the collected information for:

- Providing and maintaining the Service
- Processing your payments and subscriptions
- Improving our AI form-filling capabilities
- Analyzing Service usage and performance
- Communicating with you about updates
- Preventing fraud and abuse
- Complying with legal obligations

4. Data Storage and Security

4.1. Data Storage

- User account data is stored securely in our databases
- Payment information is processed by secure payment providers
- Form-filling data is processed in real-time and not permanently stored

4.2. Security Measures

We implement appropriate technical and organizational measures to protect your data:

- SSL/TLS encryption for data transmission
- Secure data storage systems
- Regular security assessments
- Access controls and authentication

5. Data Sharing and Disclosure

We may share your information with:

- Al service providers for form-filling functionality
- · Payment processors for subscription management
- Cloud service providers for infrastructure
- Legal authorities when required by law

We do not sell your personal information to third parties.

7. Browser Extension Permissions

Our Chrome extension requires certain permissions to function:

- Access to web page content (for form filling)

We only access and process data necessary for the requested form-filling operations.

8. Data Retention

We retain your information for as long as:

- Your account is active
- Necessary to provide our services
- Required by law
- Needed for legitimate business purposes

9. Children's Privacy

Our Service is not intended for children under 13. We do not knowingly collect personal information from children under 13.
